THE UNDERSIGNED, for the purpose of forming a non-profit corporation under the Montana Non-Profit Corporation Act, does hereby adopt the following Articles of Incorporation:

- 1. NAME: The name of the proposed corporation, hereinafter called the Corporation, is: BACK COUNTRY HORSEMEN OF AMERICA.
- 2. <u>DURATION:</u> The Corporation shall have perpetual existence, unless sooner dissolved according to law.
 - 3. PURPOSE: The purposes for which the Corporation is to be formed are:
- (a) To perpetuate the sensible use and enjoyment of horses in America's roadless, back country;
- (b) to assist the various Government and private agencies and organizations in the maintenance and management of the back country resources;
- (c) to educate, encourage and solicit active participation by the general public in the wise and sustaining use of horses in the back country, commensurate with our heritage; and
- (d) to foster and encourage the formation of local organizations to pursue the same purposes.
- 4. DISSOLUTION, WINDING UP: Upon the dissolution of the Corporation, or the winding up of its affairs, any assets of the Corporation shall be distributed exclusively to charitable, religious, scientific, testing for public safety, literary, or educational organizations which would then qualify under the provisions of Section 501 (c) (3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended.
