

# Chapter: BACK COUNTRY HORSEMEN OF EAST TENNESSEE-2024 (BCHET)

#### Accomplishments

- 1. Trails & Facilities: Cherokee NF (Northern 2 Districts Unaka Mountain and Watauga horse trails)
  - a. Existing trails: 2024 is a year none of us will ever forget. We spent hours clearing our established trails that had developed overgrowth or were blocked by blowdowns. We worked in both the Unaka and Watauga Districts on multiple work days. Our work days were successful and we were feeling quite accomplished when Hurricane Helene started her steady march toward East Tennessee and Western North Carolina leaving a wake of destruction along the way. Downgraded to a tropical storm, Helene parked over the mountains of Western NC and East TN dumping inches of rain and delivering landscapealtering winds and floodwaters. In a blink of an eye lives were lost, homes were washed away, land eroded and the rivers were reshaped forever. The Nolichucky River in Erwin, TN rose to nearly 34 feet. The Noli along with the Watuaga River in Elizabethton, TN and the Elk River east of Roan Mountain flooded entire communities. It's hard to fathom the extent of the damage. In the days following this tragedy, heros started to emerge. Phone calls, texts, and emails were firing in every direction. On of our members selflessly worked hours upon hours to coordinate supplies for our friends and neighbors. BCHET purchased a load of hay and delivered it to a local who lost all their hay in the flooding. This member worked with local distribution sites as they popped up in the affected areas to coordinate club volunteers to haul needed supplies to those that needed them most. Hay, feed, fencing supplies, buckets, and every imaginable farm item was donated and delivered either to an individual or a distribution site. We reached out to every single member by email, text and phone call to assess their needs and help in any way we could. Two of our chainsaw members removed trees off fencing for a member. Multiple donations of fencing supplies were donated to a member who lost her husband, her home, her pup and everything but her barn and her 6 broodmares and their foals. There are many stories of deep loss but there are also stories of survival. Communities came together to help one another and lend a hand when our local first responders were overwhelmed. BCHTN and our sister chapters collected funds from family and friends and donated over \$4k to our efforts. We offered the donated funds to anyone in need. A committee was formed to determine the best way to distribute the funds. As applications were received the committee made the decision on how much of the available fund each applicant would receive. To date all of those funds have been distributed. Our volunteers logged 196 hours in their Helene relief efforts.
  - b. During all of these efforts to help our community a small group of members began the process of assessing trails and getting to work on clearing them. We have a long way to go. We have many miles of trails left to clear. Trees are down in multiples, stacked on top of one another and under great tension. It's slow and tedious work. Creek crossings are washed out and, in some places, not safe to cross.

#### Current & Future Projects (Goals)

- 1. Trails and or Facilities:
- 2. We continue to work closely with the USFS on area trails to clear downed trees and repair problematic trails. We schedule a once a month work day with the USFS Trail Tech Supervisor and his crew. Brandon Church with the USFS has been a huge asset to our region. We continue to work toward a connector trail in the Walnut Mtn trail system. NEPA Study has been APPROVED!!!
- 3. We were contacted by the Johnson County Trails Association to show our support for the redesignation of the Iron Mountain Trail to multi-use with BCHET providing labor to help maintain the trail. This multi use designation would offer a long distance ride through two states on the Iron Mountain Trail, the Virginia Highlands Horse Trail and the New River Trail. A letter was penned in support of this project. The Johnson Co Trail Association has paid out over 40k for environmental studies which are complete.
- 4. Clearing trails from the aftermath of Helene is a priority.

#### **Issues and Problems**

- 1. Outside organizations
  - a. We continue to see trail use by off road vehicles in areas not open to motor vehicles. Lots of damage observed in the Limestone/ Dark Hollow area. Multiple trails on Holston Mtn have also been damaged by off road vehicles. Recently, bear hunters cut through the woods to go around a gate and access a forest service road closed to automobiles. Several gates have

had locks cut and removed, gates torn from the ground, and trail beds damaged by auto traffic.

We have observed the same user multiple times on the Holston Mtn trails with an E-bike.

#### 2. Elemental:

- a. The FS conducted controlled burns in a few areas of the National Forest this year. Hurricane Helene raged into TN as a Tropical Storm dumping inches of rain and causing historical flooding across the region. Winds and wet conditions contributed to numerous blowdowns on a majority of our trails in the eastern part of the state.
- 3. Goals for membership increase: Continue outreach and spreading the good word about BCHET and BCHA.

# Chapter: SOUTHERN APPALACHIAN BACK COUNTRY HORSEMEN-2024

#### 1. Accomplishments

- a. <u>Trails & Facilities</u>: We maintain trails in two districts of the <u>Cherokee National Forest</u> (Tellico and Ocoee-Hiwassee). We also help the BCH of North Georgia in the <u>Chattahoochee</u> <u>National Forest</u>. We work every Thursday, year-round.
  - i. Existing trails: In Cherokee National Forest South, we still had3,540.5 volunteer hours for a dollar value of \$190,992.84.
    - 1. In 2024, we sawed out 947 total chainsaw trees. In Wilderness, 294 total crosscut trees. Combined chainsaw and crosscut total o 1,231 trees!
    - 2. We maintained the following horse trails: all horse trails on Starr's Mountain, (horse zone) in the Ocoee-Hiwassee District. We also work the Tellico District including Tavern Branch/Miller Ridge. In 2024, we had a National Trails Day event in the Citico area (more about that later) We maintain 66.6 miles in O/H and 48.2 miles in Tellico for about 125 miles total maintained to standard. We also work numerous hiking only trails with our partners.
    - 3. We started a new Adopt-A-Trail program in 2023. Some trails were worked almost every month. Others only three times and some not at all (since no hours were turned in).
  - ii. At Enterprise South Nature Park, a Hamilton County (Chattanooga) managed park, we secured a used picnic table on FB Marketplace for the equestrian trails "lunch spot". The park service placed the table on January 8, 2024. Enterprise South Summit Knobs has about 16 miles of equestrian trails.
  - iii. SABCH received a plaque from Region 8 in Atlanta stating "Presented to the Southern Appalachian Back Country Horsemen For enduring service and volunteerism to the South Zone of the Cherokee National Forest seventeen years. SABCH has shown their dedication, tenacity and positive attitude towards maintaining our National Forest's trail systems. We thank you. May 2024.

#### b. SABCH Outreach Experiences

- i. We did not participate on Public Lands Day due to Hurricane Helene. We did not participate in National Trails Day 2024 at Citico in the Tellico Ranger District.
- ii. We also participated in the Tellico River Cleanup and the Hiwassee River Cleanup sponsored by Trout Unlimited in the spring.

#### c. Collaboration with Other Organizations

- i. Our chapter often assist our partners, the Benton MacKaye Trail Association, a hiking association. We work on many hiking and multi-use trails.
- ii. Had our annual meeting with the Forest Service meeting on February 28, 2024 at the Ranger Station. We also met Feb 5, 2025 for our annual meeting.
- d. <u>Membership</u>: Did a separate e-mail blast for the membership including a membership packet. Membership was \$35 Individual, \$40 family.

#### 2. Organization

It is used to report downed trees or clear trail. Only Administrators can post. Anyone in the world can comment. Suspicious comments are deleted by Admins. Most posts are reported in the monthly newsletter since some members don't FB.
- k. Our weekly workdays are reported on our FB page (by FB administrators). Sometimes we have enough people to break into two or three teams, so each photographer goes with a different team. We always try to get a picture of the safety meeting before we start the day. This helps us fill out the required FS report.

#### 3. Current and Future Projects: (Goals)

- a. We still need to DOUBLE our volunteer hours in four years to meet the National Forest Stewardship Act requirements, signed into law in the fall of 2016.
- b. Working on incorporating the younger members at the working and administrative level.
- c. Specific Trails:
  - i. We need to reopen the closed section of Conasauga River Trail #61 which was burned out, over 6 years ago. It is a connector trail from the FS road down to the River on the West end. Applied for Legacy Grant but did not get it in 2022.
  - ii. The Blue Ridge Horse Trail #62 needs is logged out and is clear from Sheeds Creek Rd to #99.
  - iii. Sylco Tail #75, has healed itself and does not need another culvert due to Easter Flooding 2021, (totally washed out). The new carconite signage installed by SABCH was destroyed by a prescribed burn in Spring 2025. Some have been replaced by painted

- blazes on trees left after the prescribed burn. Also, there is still a large sinkhole over a culvert on the old RR bed. The Forest Service is dragging their feet on this repair. It has been patched, not repaired.
- iv. Signage both parking and/or directional for most trails, including Miller Ridge, Cooper Gap, Yellow Creek, Bullet Creek, Sylco, Conasauga River Trail, Iron Mountain, Starr Mountain, and Tellico area.

#### 4. Issues and Problems

- a. The FS does not appear to want to maintain or add horse trails, and feels equestrians will age out in a few years. The weekly work crew works on more hiking than horse trails. They are not responsive to our email or calls.
- b. Goals for membership increase: Hope to work more closely with the local McMinn County Saddle Club for recon purposes. McMinn Saddle Club have several rides in the Cherokee National Forest and know where trail problems are.
- c. The new Tellico District Ranger, Andrew Connor just started at the end of January 2024. They have not hired a new Recreation Manager since Brandon Burke left in November 2023.
- d. The FS is working with us on signage as much as possible. They have given us carsonite posts and stickers, AND the driver to put them in. We also now have a gate key. This is an accomplishment! We also have permission to paint correct blazes as well. (They really have tried since the controlling person has been reassigned.)
- e. Hurricane Helene happened September 24-27, 2024. Devastation and Destruction. SABCH raised funds to assist the people of our sister chapter (BCHET) and beyond. This is huge the way we came together. We had several flatbed loads of hay, fencing and other farm equipment the destitute animal owners.
- f. SABCH was presented with 2 USFS Scoping Letters to which we had members participate.
  - a. On July 7, 2024, SAARTAB, scoping letter which was "Southern Appalachian Aquatic Restoration Technical Advisory Board" for all of Region 8, best practices authority. We responded, but the membership had difficulty at large as the recommendations were vague and all inclusive.
  - b. On October 24, 2024 the Cherokee National Forest, Tellico Region, sent a scoping letter announcing it's intent to close Little Citico Trail #3 and #4, and Youngs Horse Camp to Horses. SABCH used our alliance partners and the local saddle club. We met at their meetings were able to leave them with talking points and explained the respect we needed to grant them. Per our contact at NEPA in Tellico, all 23 letters received were surprisingly polite, "powerful", some even helpful. Their deadline to answer has long past, so with Randy Rassmussen's help we may make some headway.
  - 2) Our Adopt A Trail program is being managed much closer by a member who has interest and time. This creates awareness and a sense of purpose in the club. We purchased a new laptop when Tennessee had a tax free weekend for "back to school" purchases. Even though we are a 501c3, our local WalMart had restrictions-best to do a work around.
  - 3) Signage: Finally, we were given another FS gate key, mostly for the purpose of putting up signage. We also were given by the CNFS, a set of carsonite posts, stickers to create the signs and a driver to slam the posts into the ground. We have now marked all of Sylco and Burkett Iven trails. Now we need more carsonite posts but the FS has no budget.

# Chapter: BACK COUNTRY HORSEMEN BIG SOUTH FORK-2024

#### 1. Accomplishments

Our members participated in *monitoring* the status of trails throughout the park as part of the park's Trail Keepers program. As part of this program, our members performed routine trail maintenance and sent reports to the park on trail conditions. The Big South Fork Superintendent will not allow volunteers to use power tools including chainsaws.

All of our monthly meetings are open to the public. The 2024 BCH-TN Rendezvous that we hosted was also open to the public. We often have people who are not members attend our meetings and events. We do a lot of outreach via our Facebook Group and one-on-one conversations following a contact made through our webpage or one of our officer's email addresses.

#### Education

We regularly post educational material via our Facebook group. Sometimes we schedule special educational sessions. In 2024, we held a special session to address how one can track a horse that has become lost in a remote area such as BSF National River and Recreation Area.

- 1. We're a Tennessee 501(c)(3) corporation.
- 2. We had twelve chapter meetings.
- 3. We had twelve Board of Directors meetings held jointly with the chapter meetings.
- 4. Our elections are held at the December meeting. The new officers assume duties January 1.
- 5. We had 12 newsletters.
- 6. We now have two certified chain sawyers, even though the BSF Superintendent will not allow them to utilize their skills within the park.
- 7. The <u>website</u> is <u>www.bchbsf.org</u> which is not highly used except upon direct referral by one of our members.

- 9. The <u>Facebook</u> has 10,991 likes and 1,804 members, active members per week around 450. The primary FB Administrator is Steven Corley

#### Goals

1. A new leadership team was installed in November 2020. This team started with essentially a "blank slate" and has worked since then to rebuild and grow this chapter. A lot of things were tried, some of them worked. There is now a reasonable knowledge base regarding how to help the park and how to grow our membership. That knowledge

was acquired through an intensive, unsustainable level of effort by the 2020 to 2024 leadership team.

Now that some of the groundwork has been done it's time for a new leadership team. One that can bring new strengths and that can take this chapter to the next level. One that can maintain and grow our membership. One that can do more trail work in the park or on other public lands. One that provides additional value to our members.

A number of dramatic changes in our chapter practices are in order. These will maintain and add activities that have a high return for the time and money invested in them. Activities that have a limited return, perhaps because the new leadership team has a different skillset, will be reduced. Engagement by more members in chapter activities will be promoted.

The members of the new leadership team will work with the members of the old leadership team so that there's a larger pool of very active members and lessons learned in the prior four years are made available to the new leadership team.

#### Issues and Problems:

- 1. The new leadership team will seek to build on the relationship established with the park by the outgoing leadership team. There's very likely a way that we could assist the park with the work on the Kentucky Connector Trail. We've found that a great way to work with the park is as an embedded member of one of the park's trail crews. They provide transportation to and from the job site and make available equipment that volunteers aren't authorized to use.
- 2. The new leadership team adds expertise in packing and clearing using chainsaws and crosscut saws. There may not be an opportunity to use those skills in the park. We have other members who are able to do serious trail work but haven't been allowed to do that in the park. The new leadership team often works on other public lands. This could provide an opportunity for our chapter to do such work in public lands beyond the BSFNRRA.`
- 3. Outside organizations: From the superintendent down, the park is a very closed and tightly managed organized organization. No change in this is anticipated in 2024. We continue to explore ways that we can help the park that the park and our members will both accept. To be clearer about that, we have quite a few members who would be willing to do more but not under the severe constraints placed on them by the park. Many of those constraints are also placed on the park staff so, they may in fact be appropriate. They do however, limit the amount of volunteer participation in the park.
- 4. Our members tend to be older, retired, and female. We have few members that are willing and able to do a lot of volunteer work in the park. So, our volunteer hour contribution to BCHA is likely to be lower than the national average. Accepting this, our focus has shifted towards building an equestrian community that supports the park in other ways and that supports BCHA through membership dollars. We reached 120

memberships in 2024. This was a big push. We will try to maintain this level of membership in 2025.

## Dues Structure:

- 1. Individual Dues are \$30/yr.
- 2. Family Dues are \$40/ yr.
- 3. All annual dues expire December 31. There is no online option. The 2025 board is looking into offering this in the future.
