Underserved 2-3:1 vs other committee

- Randy (and/or BCHA Chair) participates in the AHC annual meeting held in June, in Washington D.C.
- Weekly communication with AHC President and/or Staff

Accomplishments:

- At BCHA's request, AHC met with staff of Sen. Lee (UT) to express concern about his Bikes-in-Wilderness bill and offered to circulate a letter of opposition to the bill and would encourage the Outdoor Recreation Roundtable and state horse councils to sign on.
- Assisted BCHA in negotiating language of Biking on Long-Distance Trails (BOLT) Act between committee staff of the House Natural Resources Committee and People for Bikes. The bill became law and included the language changes requested by BCHA.



Partnership for the National Trails System (PNTS)

PNTS is a convenor of Hike the Hill and National Trails Workshop. *More detailed information will be presented on Tuesday.*

Participation:

- Randy serves as Chairman of PNTS Membership Committee – Quarterly meetings
- Randy serves on the Advocacy & Policy Committee – Monthly meetings
- Randy and BCHA Chairman and BCHA Vice Chair participates in Hike the Hill – Annually
- Randy usually attends National Trails Workshop – Annually
- Regular (often weekly) communication with Executive Director and/or Staff

Accomplishments:

- BCHA is the only equine-related member organization
- As participant in Hike the Hill, BCHA gains added access with agency leadership and congressional committee staff
- BCHA input is sought on annual appropriations requests to Congress regarding priority funding needs of the federal land management agencies.

National Wilderness Stewardship Alliance (NWSA)

NWSA co-convenes the National Wilderness Workshop

Participation:

- Randy serves as BCHA representative on the Trail Stewardship Partner grant team - Annually
- BCHA is the only equine organization among the grant review team for Trail Stewardship Partner grants

Leave No Trace (LNT)

BCHA is disappointed to see LNT has removed the horse from the widely accepted Yield sign

Participation:

- BCHA maintains relationship with LNT and facilitates LNT Master Stock Training certification services
- There are LNT Master Stock Trainers across BCHA membership
- LNT is complementary to BCHA Light On The Land

Coalition for Recreational Trails (CRT)

CRT is the only entity that lobbies for the enhancement and expansion for the Recreational Trails Program and convenes the annual RTP Awards Ceremony on Capitol Hill.

Participation:

- Randy serves as BCHA representative on Board of Directors – Monthly
- BCHA is the only equine organization that regularly participates in strategy and planning related meetings –As needed

Accomplishments:

- Bipartisan introduction in Congress of the RTP Full Funding Act – if passed, will more than triple the amount of RTP funding



- Funding Opportunities – RTP Grants independently administered by each participating State (currently CT and IN do not participate)
- Budget fee requested: \$500.00

American Hiking Society (AHS)

American Hiking Society convenes Hike the Hill and is lead in developing appropriations request documentation.

Participation:

- Randy maintains regular contact and communication with counterparts concerning issues such as the trail's community annual appropriations request, pending threats associated with e-bike use on horse/hike trails and threats to the Wilderness Act that would authorize bike use.

Accomplishments:

- Annual appropriations request amended to include specific language suggested by BCHA.

International Mountain Bicycling Association (IMBA)

Participation:

- Randy served on the IMBA Steering Committee for Trails are Common Ground campaign organized to share information about proper trail etiquette – recently dwindled out.

Accomplishments:

- Supports BCHA position of bikes not allowed in Wilderness

Equestrian Land Conservation Resource (ELCR)

Participation:

- Randy interacts with ELCR Executive Director largely through AHC Recreation, Trails and Land Use Committee
- Occasionally ELCR and BCHA share and co-host webinars



The Wilderness Society (TWS)

Participation:

- Communication is dependent on the status of on-going issues

Accomplishments:

- Key supporter against Bikes-in-Wilderness bill
- Supports BCHA ongoing work against E-Bike use on otherwise non-motorized trails
- Continues to support BCHA as lead against authorization of E-Bike use on non-motorized trails in the absence of stakeholder engagement and environmental analysis

Corporate and Business Partners

- Legacy Radio: They allow us to go on the radio and talk once a month.
- Trailmeister: Verified by the areas land manager.

Call for any unfinished business:

Q: What requirements are there for someone who might be considering running for the EC in the future and what are the time commitments?

A: Experience, time in BCHA, and the commitment for officers is probably an extra hour a month.

How did the states who went through the Natural Disasters fair, how did they prepare and deal with the aftermath?



Asking as an individual and as a chapter.

North Carolina provided what they did. What they are worrying about is getting the chapters what they need to help get trails open, cleared and recreated.

Discussion continued through states as to what they need and suggestions.

For events: Have a designated safety officer.

Fires in California, working with different groups from moving hazardous waste to working trails. Make yourself available to help in any way we can.

Kansas: 2019-thousand-year flood, trails never came back in an area.

New Mexico: Extreme draught.

Indiana: Trees are old and dying, storm comes, and the trees go over. Some trails do not open after 3 or more years due to storm. Tornadoes. Need chainsaw certification. But not devastated like some other states. Indian Forest Alliance fights at every corner to stop the Forest Service from working in the forests.

Missouri: Flooding and ice storms.

Kentucky: Rains and Flooding, tornadoes. Suggestion that if you need to evacuate your livestock, work with arena's who have disaster plans in your area.

Oregon: Prepared disaster plan on how to evacuate livestock with the county and fire; partnership. They are on the board on the equine disaster with the state.

South Carolina: Hurricanes. They have a network in the communities who will help.

Arizona: Fires are the biggest problem

Alabama: Tornadoes, hard to evacuate with little to no warning.

Georgia: Tornadoes, wind, fire

Texas: Fire, mostly on private ranches. State parks have their own program you need to go through.

Tennessee: Flood, people were unreachable due to down phone lines and cell towers.

Alaska: Fires

Colorado: Fires. Training people to safely pack supplies, tools, and personal to remote areas to help rebuild the forests and infrastructures.

Montana: Fires and straight-line winds

Utilize the minimal tool requirement, please reach out to the regional public lands and then reach out to Brad Pollman, National Public Lands and they will help you with this.



Hurricane Relief Funds: This was given to states to help rebuild trails.

Take the first chair letter in June and designate Relief Funds for future disasters.

Motion to allow states to use as they deem necessary

BCHA would award the state too, and the state would submit to the chapters in need.

Motion to start an emergency relief fund where the funds may be used outside the mission statement, and the June Chair letter will address the disaster funds.

RESINDED

- The EC should be the entity to disperse the funds.
- Further discussion as to what the states did with the funds for Hurricane Helene.
- In the event there are no disasters, this account will roll over year after year.
- Next year to have a resolution for the disaster funds

*****Motion to establish a disaster fund, it will align with mission statement. The first chair letter to start this fund and then allow the Chairman to establish a committee to disburse the funds. Seconded. Motion passed.***

Partnership line item: Suggested to include Back Country Hunters and Anglers to partner with, cost approximately \$250.

*Rocky Mountain Elk Foundation

Maybe we should remove LNT. Further discussion regarding if LNT has left equine. Research suggests that we are not on their website.

*Public Lands Foundation is a national membership organization.

Education: What is the increased cost for? Videos for Light on the Land.

Comments: Have more detail regarding the cost of videos to make this simpler.

Bank Fees – Why is there no budget. These fees are blank because they are included in Administration General.

Fundraising: Do we need a line for fundraising expenses?

Income: Chapter Support Grants, why is it only at \$2500 when we brought in over \$7,000? We don't base this on the previous year's income. Same with miscellaneous income.

Public Lands Travel: Why a lower budget? We don't intend for Randy to have as much travel.

General Travel:

Suggestion to leave travel at \$8000.

Comment: If expenses increase, we must find new ways to raise income.

Comment: There is only so much money in the room, and we are including a new fundraiser for disaster, we need to think about this.



Do we have a fundraising committee? No that is under the Executive Committee.

Partnerships

Back Country Hunters & Anglers: They are set up just like BCHA and their mission aligns very closely with BCHA.

Rocky Mountain Elk Foundation: Concentrates solely on wildlife management and research. Worked on Elk reintroduction. They were not very successful in reintroduction except for their limited equestrian access.

Public Lands Foundation: Mostly Bureau of Land Management. Suggested this would be a bit redundant in comparison to who we already work with.

Public Lands Alliance: Connect Strengthen Represent. The sole purpose is to advance their members. Suggested, a formal partnership is necessary.
